1) Beyond Appropriations: Changes and Opportunities in Housing Policy

However, there are major changes in tax policy and housing finance under discussion in Washington and around the country which could lead to sweeping changes in housing opportunities for our communities. 3) Section 8 in an Age of Shrinking Resources

Section 8 Rental Assistance is the nation's largest, and one of its most successful low-income housing programs. Over 260,000 New England households receive some form of assistance. Given the realities of the federal deficit and significant underfunding proposed for FY 13 by both the House and the Obama Administration, what is the future of Tenant and Project Based Rental Assistance? What are the prospects for legislative reform through the Affordable Housing and Self-Sufficiency Improvement Act (AHSSIA)? How are local PHAs dealing with reduced administrative fees and reduced Fair Market Rents? How could a new proposal for a renter's tax credit complement Section 8 in an era of shrinking resources? Come hear details about what lies ahead for Section 8, both in the form of legislative changes and funding realities.

4) Public Housing: A Perfect Storm

Cash-strapped Public Housing Authorities (PHAs) are used to doing more with less, but some changes on the horizon signal a "sea change" in the way PHAs will deliver housing. From the Rental Assistance Demonstration to Operating Reserve offsets to a growing emphasis on resident participation, there is a new normal emerging. To remain vibrant and effective, PHAs must both resist harmful changes and embrace those that can advance their missions. 5) Supportive Housing – Best Practices, New Challenges, and Opportunities

Supportive housing is a proven success for ending homelessness and creating community inclusion for people with disabilities. While the needs have grown, waiting lists for services and shrinking resources have posed threats to the ability to create this important resource. However, these threats have spawned the creation of new models with broader applicability. Some new tools include the new streamlined HUD 811 which will allow supportive housing to be better integrated to LIHTC affordable housing developments, opportunities presented with Medicaid expansion and the Affordable Care Act, and the use of technology to keep people successful in their homes with dramatically less intrusive staffing. This workshop will discuss effective models for serving people who are homeless, people who are elderly, people with developmental/intellectual disabilities, and people with mental illness/substance abuse issues.

6) Foreclosures and Neighborhood Stabilization

Foreclosures have disrupted lives and destabilized neighborhoods throughout New England. After four years, the foreclosure crisis is not over, but new efforts are under way to assist impacted homeowners and communities. Continue on I-495 North for about 25 miles. Take Exit 22 (Massachusetts Turnpike/Interstate 90 East) towards Boston.


