1. Beyond Appropriations: Potential Sweeping Changes in Housing Policy

As practitioners and advocates, we tend to focus on the funding side of what's happening in Washington. Yet, we must heed the warning that "everything is on the table now." There are potentially significant reforms being discussed regarding tax policies, regulations, agencies, and programs. Elimination of the HUD Housing Counseling Program in the FY11 budget has brought the importance of housing counseling sharply into focus. Pre- and post-purchase homebuyer counseling has a proven track record of preparing potential homeowners to buy homes, as well as keeping those delinquent on their mortgages in their homes. With the continued high rate of foreclosures and a very challenging lending market, housing counseling will still be essential. 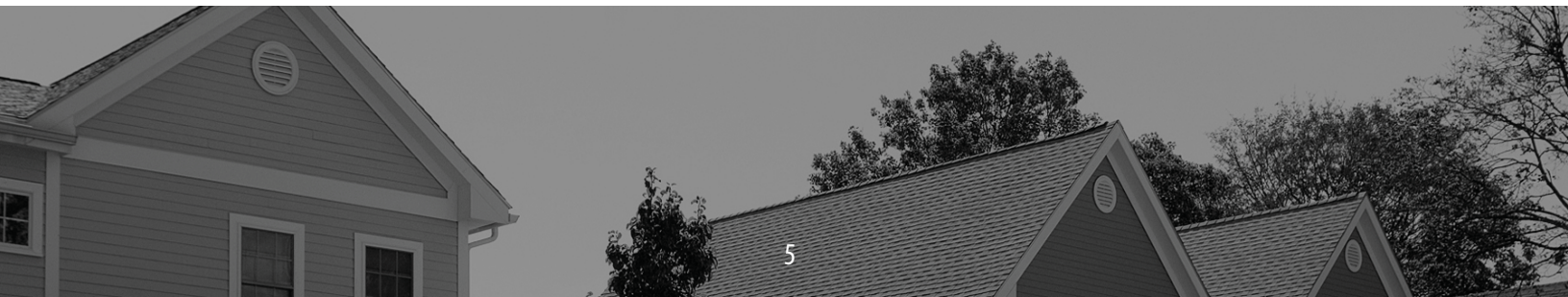

From the North:

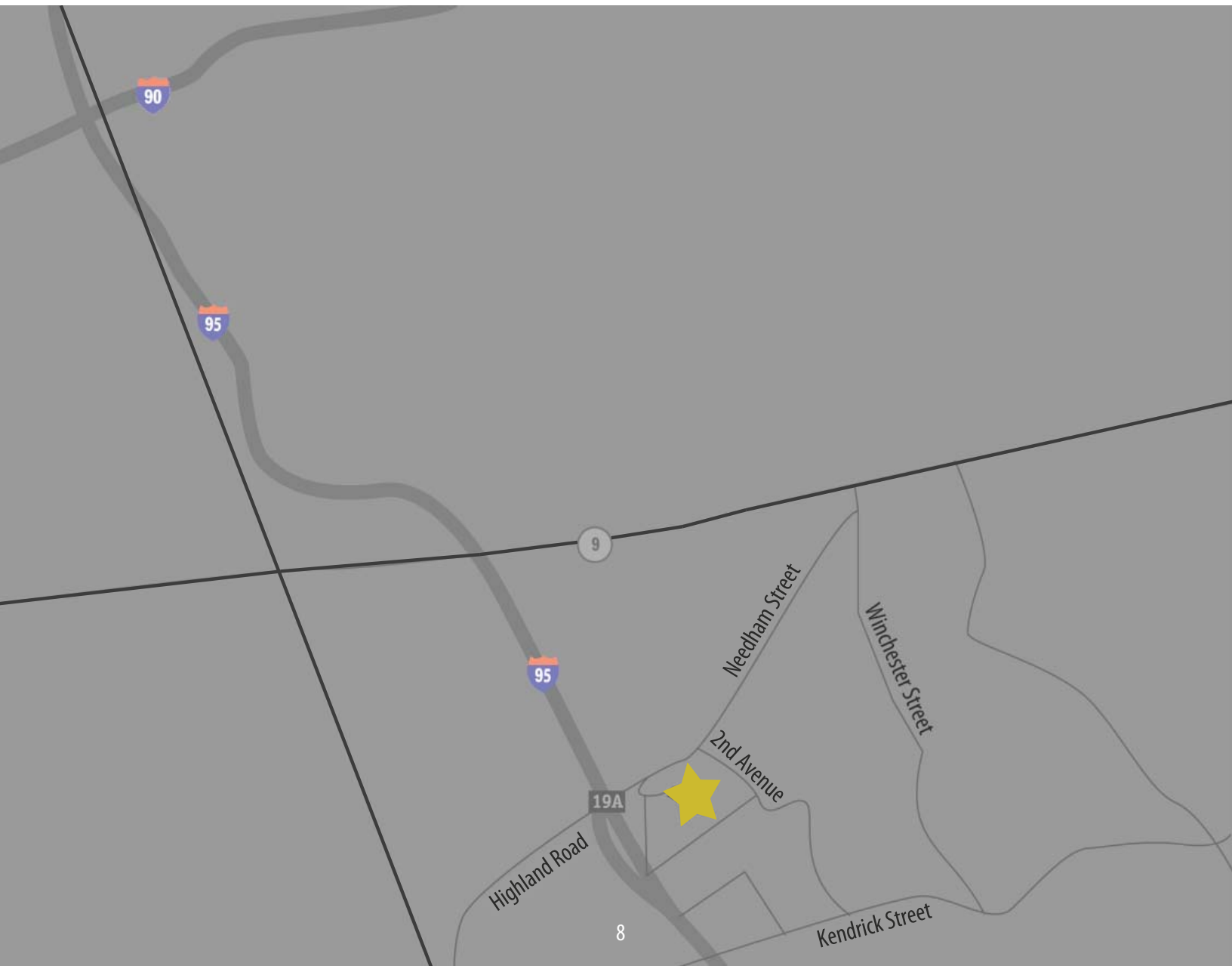
