State Updates

Governor Enacts COVID-19 Data Law with Reporting Requirements for Senior Affordable Housing

On June 7, Governor Baker enacted a COVID-19 data law with new reporting requirements for public and affordable housing for seniors and persons with disabilities, requiring them to report any known COVID-19 cases or deaths among residents or staff to the Department of Public Health and local boards of health. The law also requires these housing providers to notify residents and their healthcare proxies by the following day when there is a COVID-19 case or death, or if 3 or more residents or staff present with respiratory symptoms within the previous 72 hours.

Boston Makes \$5 Million More Available for Rent Relief

The <u>City of Boston will make another \$5 million available</u> for its Rental Relief Fund, in addition to the \$3 million that the fund launched with in April. To qualify for the assistance, a Boston household must have an income at or below 80% of the area median income. Approved recipients can get up to 3 months of rental assistance, with a maximum benefit of \$4,000 for a 12-month period. Priority will be given to applicants who are ineligible for unemployment insurance or do not receive the full amount. Applications for this round of rent relief funding opened on June 5 and will be due by Friday, June 19.

Moratorium in Court Two landlords have challenged the statewide eviction

moratorium in court. The suit, filed with the Supreme Judicial Court, seeks to overturn the moratorium, claiming the law is unconstitutional, violates the right of landlords to access the courts, and represents a seizure of real estate without proper compensation. If successful, the challenge could allow thousands of evictions to proceed when state courts reopen this summer. The court is expected to hear the case later this month.

DHCD & CEDAC Announce \$16 Million for Affordable Supportive Housing

Earlier this spring, <u>DHCD and CEDAC announced funding</u> awards for the annual affordable supportive housing round. Awarded projects will provide affordable housing with supportive services for families and individuals who have experienced homelessness, older adults, and individuals living with disabilities. The projects are located in metro Boston as well as the central, western and northeast portions of the state.

DHCD Releases NOFA for CDBG Funds On May 15, <u>DHCD released a Notice of Funding</u>

Availability (NOFA) for \$19.65 million in Community

Development Block Grant (CDBG) funds authorized by the federal CARES Act. The funds are available to nonentitlement municipalities and their residents. Up to \$10 million will be made available for rental and mortgage assistance, and \$9.65 million will be allocated for public social services and micro-enterprises assistance. Applications are due on Friday, June 12, 2020. DHCD will continue to accept applications on a rolling basis after June 12 but will prioritize those submitted by the due date.



Development (HUD) issued the remaining \$2.96 Billion of ESG Funding from the CARES Act. Massachusetts' ESG program received \$73,604,660 in funding.

The PPPFA extends the loan disbursement period from 8

HUD Issues Funding for New Section 8 Vouchers On May 18, the <u>HUD allocated \$77 million in Coronavirus</u> Aid, Relief, and Economic Security (CARES) Act funding to public housing authorities to support up to 8,300 new Housing Choice Vouchers. The vouchers will be awarded through HUD's Section 811 Mainstream Housing Choice Voucher program for non-elderly individuals with disabilities.

On May 15, the <u>House of Representatives passed the</u> Health and Economic Recovery Omnibus Emergency Solutions Act (HEROES) Act to provide \$3 trillion for

COVID-19 response. The bill includes widespread affordable housing investments, including \$100 billion for emergency rental assistance, a \$75 million fund to help homeowners pay their mortgages, and an expansion to the eviction and forbearance moratorium created in the CARES Act. After negotiations occur between the leadership in the House and Senate, the Senate is expected to take up a version of the bill in the coming months. **HUD Issues Second Round of CDBG Funding from** the CARES Act On May 11, <u>HUD issued \$1 billion for the second round of</u>

<u>funding</u> from the CARES Act. Of this total, <u>Massachusetts'</u> state program received \$26,083,361 for CDBG.

(NLIHC) issued its 2020 Picture of Preservation report. The report examines the role the federal government plays in building and preserving affordable rental housing and finds that only 10% of the entire rental stock - 4.9 million rental homes - is subsidized through federal project-based subsidies. **Economic Innovation Group Releases Two**

Reports on Growth of High-Poverty Neighborhoods The Economic Innovation Group issued two reports that

detail the growth and persistence of high-poverty neighborhoods in the U.S. The reports, "The Expanded Geography of High-Poverty Neighborhoods" and "The Persistence of Neighborhood Poverty," find that the number of high-poverty neighborhoods has increased, the income gap between high and low-poverty neighborhoods has widened, and the share of Hispanic individuals in high-poverty neighborhoods is growing.


