
Solar For All and Affordable Housing

Public Multifamily Program Components

- ➤ Developed in partnership with Boston Housing Authority
- Centralized procurement for design & install
- ➤ Minimum 20% tenant savings in accordance with federal (HUD) guidelines
- Ownership
 - Direct: Funds for upfront costs, cover timing gaps, and grants to enable deeper savings
 - 3rd Party: Grants to enable deeper savings and community impact

Private Multifamily Program Components

- ➤ Developed in partnership with MassHousing
- ➤ Minimum 20% savings Targeted incentives to account for project specifics
- Ownership
 - Direct: Bridge loan for initial costs and to cover timing gaps, forgivable portion to enable deeper savings
 - 3rd Party: Grants to enable deeper savings and community impact





Solar For All and Affordable Housing

ADDITIONAL PROGRAM SUPPORT

- ➤ Technical assistance to support application process and decision making (i.e. what ownership model works for me?)
- Enabling upgrades to ensure property is suited to host solar
- Published funding formula to aid in financial modeling

NEXT STEPS

- Currently contracting with EPA though September 2024
- Refined program design this summer and fall with opportunities for stakeholder engagement
- ➤ Programs launching early as fall and winter 2024



Appendix - Solar For All: Program Overview and Timeline

- ➤ MA was awarded \$156M, the maximum awarded to any applicant within the medium category
- ➤ Funding is for a up to 5-year program to expand access to solar for "Low Income and Disadvantaged Communities"
- ➤ SFA is aligned with state's solar targets, environmental justice objectives, and ongoing reassessment of state solar policy
